John Kruschel N73W24680 Peterson – Would like to know where the water from the retention pond is going to go when the pond gets full and how will the construction traffic flow. – storm sewer pipe from pond to catch basin. Engineering department is working with the developer.

The plan is for an east side swail to take water to the pond and a storm sewer pipe from the pond to catch basin. Because of that they do not have the room to add a berm on the east side. The developer is working with the village engineering department on this.

The cul de sac road has been shortened and rear setbacks have been increased at the request of the village Plan Commission.
