**RE:** Hiring Process Timeline for Full-Time Lieutenant Position

The 2020 Village of Sussex Budget has appropriated the funding to add three Lieutenant positions to the current fire department staffing levels. These positions will be assigned to a 24/48-hour shift schedule and are included in the minimum staffing model of 3 on-duty personnel. The preliminary process mirrors that was used with the full-time firefighters in 2019.

**Recruitment and Application:** Job opening will be sent out via social media, professional organizations, and other sources used by the village. Application period will be open for 30-days. Completed applications will be screened for qualified candidates.

Target Date: February 28, 2020

Written Aptitude Assessment: Qualified candidates will be invited to take the written assessment. This test will be scheduled by the applicant and taken by appointment at the Village of Sussex Civic Center. Target Date: March 13, 2020

**Panel Interview:** Qualified candidates will be invited to participated in a structured oral interview with Village of Sussex Fire Chief, Assistant Village Administrator, and other Fire Service Professionals. **Target Date:** April 3, 2020.

**Fire Commission Candidate Interviews:** Finalists will be scheduled for an interview with the Board of Fire Commission and Village Administrator. **Target Date: Late April 2020** 

**Conditional Offer of Employment:** Final Candidates will receive a conditional offer of employment Subject to successful completion of Background Investigation, Psychological, and Medical Examination. **Target Date: May 2020.** 

- Background Investigation Conducted by Waukesha County Sheriff's Department
- Psychological Examination Conducted by Dr. Craig Childs, Delafield, WI
- Medical Examination and Lifting Test Conducted by ProHealth Care Occupational Health Services

Final Appointment by Board of Fire Commission: Target Date: June 2020

**Recommendation:** Staff recommends the hiring process as outlined above. Additionally, staff wishes to discuss the minimum requirements for the position with the BOFC, specifically the CPAT.
