

Re: Water Utility Vehicle

The 2006 Ford E-250 van is due for replacement. The van is now 14 years old and is need of a variety of costly maintenance. Staff has determined that replacement of the van with a utility truck, rather than a van, will better suit the water utility's needs.

The 2006 Ford E-250 will be put up for auction on the Wisconsin Surplus website once we have received the new truck. That money will be used to offset the costs of the new truck purchase.

There were 3 quotes obtained for the truck chassis as well as the service body.

Recommendation

Staff recommends the purchase of the truck chassis from Badger Truck which is the lowest bidder. Casper's Truck Equipment is the low bid for the service body also recommended by staff. The total cost of the utility truck will be \$51,636.00. This is well under the approved \$60,000.00 in the capital outlay of the 2020 budget.

Re: Maple Avenue Reconstruction - Update_

We thought it was time to give the Committee a more in depth update on the Maple Avenue projects. Overall, the Maple Avenue Reconstruction and Main Street resurfacing projects are either on or ahead of schedule. One benefit of the COVID 19 crisis and the school closures is that there is less traffic on the roads, making it easier and faster for the contractors to do their work, and allowing staff to consider some changes to the construction sequence to speed up the process.

Maple Avenue Reconstruction #1 – Main Street, Maple South and Maple Central

The substantial completion date for this project is October 30, 2020. According to the contractor's original schedule, they planned to be done in late September. We are tracking ahead of that schedule.

Main Street Repairs and Resurfacing: The underground utility work is done except for the trenchless relining of the sanitary sewer so it's time to start putting the road back together. Concrete work is getting started and will continue through mid-late May with curb, driveway and sidewalk replacements, the sidewalk extensions, and the repairs to the old concrete roadway pavement. Light bases and conduit have been installed. The contractor has taken delivery of the light fixtures, but delivery of the light poles is still a few weeks out. The new street lights will be installed and energized after they arrive. We are on track to be done with this portion of the project in mid to late June, except for the pavement marking.

Maple Avenue South: Most of the grading is done except for a 400 foot stretch of ½ of the road between Maple Grove Lane and Clover Drive where we had to wait for a previously unknown gas relocation to be completed. That gas relocation was completed on April 29th. With the schools being closed, we were able to adjust the construction sequence to speed up the grading in this section. Some of the sanitary, storm and water main work is done. The contractor has about 2-3 more weeks of work left on the underground utilities. We are on track now to begin paving this section in June, which is about 1 to 1.5 months ahead of schedule. If the weather and circumstances continue to be favorable, we could be done with this section in late July / early August.

<u>Maple Avenue Central</u>: Some of the sanitary work is done. Grading will start in earnest next week. There is more sanitary, storm and water main work to be done after grading and before paving. This section is about 2 weeks ahead of schedule now, so we are on track to be done in September.

Maple Avenue Reconstruction #2 – Maple North

The substantial completion date for this project is October 16, 2020. This section has had a little bit slower start. Some of the storm sewer is done, but we had some delay due to AT&T being behind schedule on completing their relocation. Sanitary sewer installation is expected to start sometime next week and grading is expected to start in mid-May. Right now, we are on schedule to meet the October 16th deadline per the contactor's original schedule. We're hopeful that we can speed up a bit now that AT&T's work is done.

Communications

We've been working hard to keep the public up-to-date with the project. We send a bi-weekly update on the project to residents living along the corridor as well as those who have signed up for "Road Project Updates" through the website. The Village sends letters to those impacted when there are changes to traffic patterns, driveway access, or mail delivery. Staff also collected phone numbers and email address during the planning stage of the project. Those phone numbers are now being used by the contractor and inspector in emergent situations.

Miscellaneous

- Public works continues working in 3 teams that do not intermingle due to the COVID-19 epidemic. Each team includes staff with expertise in water and sewer. Those teams rotate between streets, water and sewer on a weekly rotation. One benefit of this system is that each employee has opportunities for in depth cross training, including the supervisors.
- Staff will be interviewing candidates for our open Streets position next week.
- The Yard Waste Site will be open Saturdays and Mondays starting May 2, 2020. The site will be closed Memorial Day weekend.
- Staff is monitoring the grass growth along Good Hope Road. Last October, we had the entire road corridor re-seeded and also completed a weed and feed application. With the cold temperatures, we have not yet seen the fruits of that operation, but expect to see some growth in the next week as temperatures warm. Staff has a walk through scheduled with the Good Hope Road contractor and landscaper late next week to review the condition of the turf restoration and trees and shrubs planted along the corridor. The contractor will then need to address any identified issues per the warranty period in the contract.
- Staff has reserved 2,100 tons of salt for the 2020/2021 winter season, which is about our 6 year running average of salt use plus a little to account for the increases in lane miles for new subdivisions. For the 2019/2020 season we had reserved 2,000 tons but only used 1,350 tons due to the mild winter. We only pay for what we use.

Developments:

- Woodland Trails: Blasting and grading activities are underway throughout the development. Utility installations are also restarting now that the site has dried out. This also means that trucking of material into the site along Woodland Creek Drive will be starting again soon. Residents along Woodland Creek Drive have been notified.
- <u>Vista Run:</u> The preliminary plat, grading plan and preliminary utility layout have been reviewed. Developer will continue with the approval processes in the coming months but likely won't start construction until Spring 2021.
- <u>Highlands / Basting Farm:</u> Construction along CTH K and STH 164 is underway with the goal of completion by July.
- <u>Sussex Preserve Phase 3:</u> The plans for the last phase of this development have been submitted and are under review.
